Please mark if your phone is a mobile number or other and if you authorize text messages. Artist name **MUST** be written on the artwork. Contest is open to all children meeting the age requirements. A child support case is not required for participation.

### Art Requirements

Complete a drawing based on the age group directions using only the approved materials including finger paints, crayons, markers, colored pencils, paints, pastels, decoupage, or collage.

Entries should be submitted on paper not to exceed 11" x 17". A short poem or paragraph for age group 13-19 **MUST** be submitted handwritten or typed on a standard size notebook paper or 8.5" x 11" paper.
